SCHOOLS IN OUR CONSTITUENCY WILL SEE NEW RELOCATABLE CLASSROOMS AND UPGRADES IN BANDWIDTH!



As I have been knocking doors and meeting with people in our constituency, I have heard concerns around the need for upgrades to bandwidth and the need for relocatable classrooms. I was thrilled to join the Honourable Don Morgan last week as he announced major investments in education on behalf of Premier Wall and the Government of Saskatchewan.

Education Minister Don Morgan joined students, teachers and school division officials to make two major education funding announcements that total \$20 million. The government announced the reallocation of \$16.6 million for the purchase of 46 new relocatable classrooms across the province, as well as moving nine other relocatables from site-to-site. The announcement is being made today so these classrooms can be in place for the start of the 2016-17 school year. "Even in times of spending restraint, our government believes it's vital to continue supporting schools and communities experiencing rapid growth," Morgan said. "Relocatable classrooms allow our school divisions to be flexible and to accommodate changes in enrolment as our communities continue to grow and develop in Saskatchewan. This important investment will ensure that the needs of our province's students and teachers are put first."

Morgan also announced a \$3.4 million grant for CommunityNet, which will provide for continued bandwidth upgrades in provincial schools where needed across the province.

"We appreciate the provincial government's ongoing commitment to education," Saskatoon Public Schools Board Chair Ray Morrison said. "The new relocatable classrooms will help us ease pressure in schools experiencing space constraints due to growing enrolment. With the increasing usage of technology in the classroom, the investment in network infrastructure is a step in the right direction to addressing the bandwidth issues our schools have been experiencing. Providing supportive learning spaces and innovative educational opportunities will foster our students' growth and help them reach their potential."

CommunityNet connects educational facilities, Saskatchewan schools, regional colleges and public libraries, health agencies and government departments and agencies into a private network, offering high speed broadband services to both urban and rural areas.

As part of the program to increase bandwidth, SaskTel will assume administrative responsibility for the network and begin making necessary investments to provide the new bandwidth in the coming weeks.

PREMIER WALL WELCOMES NEW ENERGY INVESTMENT IN SASKATCHEWAN



Husky Energy Projects to Create 90 Permanent Jobs and 500 Construction Jobs

Premier Brad Wall today joined Husky Energy President and Chief Executive Officer Asim Ghosh and local dignitaries at an event celebrating the opening of the Edam East heavy oil thermal project, located near the Village of Edam.

The new plant, which has the capacity to produce 10,000 barrels of oil per day, is the first of three heavy oil thermal projects Husky will bring online this year. Each plant will create up to 30 permanent jobs and up to 250 jobs in the construction phase.

"We're working hard to create the Saskatchewan advantage and we're grateful for Husky's commitment to our province," Wall said. "Despite low oil prices, our province's energy sector continues to attract billions of dollars in new investment. That's another indication our diversified, resilient economy is weathering the economic uncertainty and continuing to create opportunity for Saskatchewan families."

PRIVATE-PAY MRI SERVICES BEGIN IN SASKATCHEWAN



Released on March 1, 2016Patients now have the option to choose to directly pay a private facility for a Magnetic Resonance Imaging (MRI) scan in Saskatchewan. Facilities that conduct a private MRI scan must also provide a second scan at no charge to an individual who is on the public waiting list.

The MRI Facilities Licensing Act, the corresponding MRI Facilities Licensing Regulations and The Medical Care Insurance Beneficiary and Administration Regulations were brought into force on February 29, 2016.

"Our government is committed to providing patients with more choice over their care decisions," Health Minister Dustin Duncan said. "Saskatchewan people who choose to pay for an MRI can now access that service right here in their own province, while also providing additional capacity within the public system." THIRD QUARTER REVENUES ARE DOWN BUT FOUR YEAR FORECAST SHOWS IMPROVEMENT

Finance Minister Kevin Doherty March 1 said provincial revenues took a big hit in 2015-16 because of the dramatic drop in oil prices but global economic recovery over the next few years coupled with Saskatchewan's strong economic fundamentals means the province's finances are expected to improve. Doherty released the 2015-16 Budget Update and Four Year Forecast today.

The Government of Saskatchewan is forecasting a deficit of \$427 million for the 2015-16 fiscal year. The deficit projection is \$165 million larger than the \$262 million deficit forecast at mid-year.

"We have seen significant and sustained declines in oil prices impacting our revenue," Doherty said. "While we have forecast a deficit this year and anticipate a more modest deficit next year due to continued low commodity prices and a weak global economy, our four year forecast projects improvement and a return to surplus in 2017-18. "As revenues recover, our government will continue to control spending in order to ensure a return to surplus. Our goal is to maintain overall spending increases of 2.3 per cent per year, which is about the same rate that we have averaged over the past few years."
