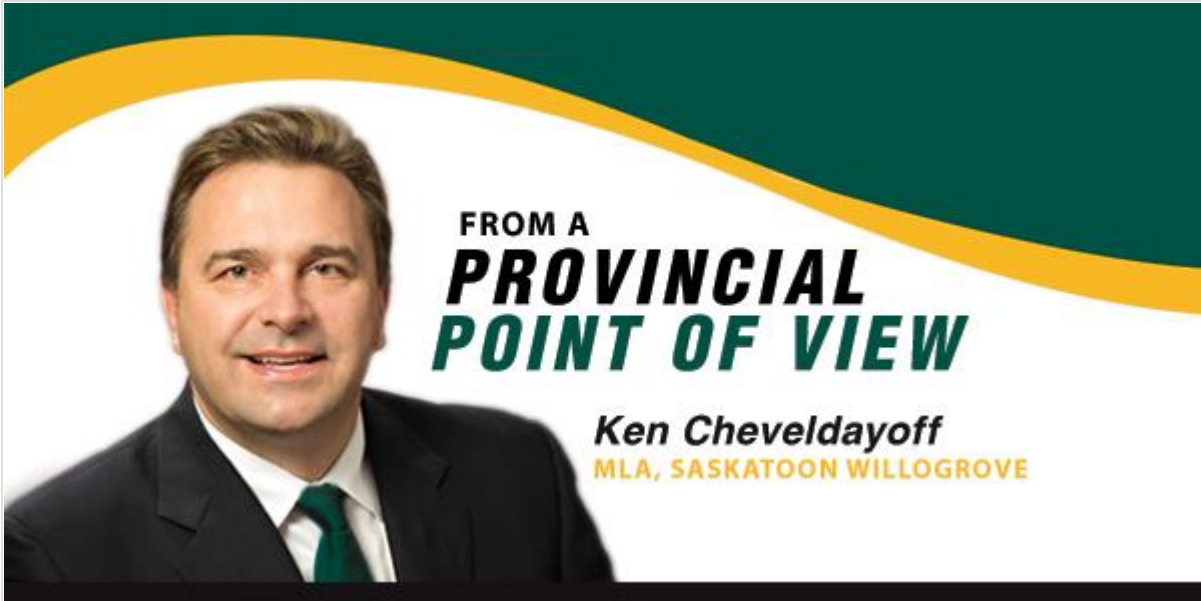

**FIRE BAN IN PLACE FOR CROWN LAND, MOST PROVINCIAL  
PARKS SOUTH OF CHURCHILL RIVER**

# FIRE BAN

**Due to extreme fire hazards, a fire ban has been issued for ALL provincial Crown land, parks and recreation sites south of the Churchill River, excluding Cypress Hills Interprovincial Park.**

All open fires in these locations are prohibited.



For cooking and heating purposes, the following items are permitted during the ban:

- Self-contained heating devices\*
- Gas barbecues\*
- Propane fire pits\*
- Charcoal briquettes used in park-provided barbecues and fire pits

\*must be CSA approved

The fire ban will stay in place until conditions improve and the Ministry of Environment rescinds the order.

Support fire suppression efforts. If you see a fire, report it by calling Park Watch toll-free at 1-800-667-1788.

In an emergency, call 911.

**The Ministry of Environment has issued a ban on all open fires south of the Churchill River to the U.S. border effective immediately, due to dry conditions.**

**The ban applies to all provincial Crown land, burn notification areas, and provincial parks and recreation sites within the ban area. This includes Clearwater River and Lac La Ronge provincial parks, but excludes Cypress Hills Interprovincial Park, where fire hazards are lower.**

**Municipalities, regional and national parks may also ban open burning in their areas of responsibility. **Check with your local authority to find out if there are burning restrictions in place for your area**

or where you plan to travel.

No open fires or fireworks are permitted for the duration of the ban. Self-contained heating devices, pressurized stoves, gas barbecues, propane firepits, or charcoal briquettes used in an approved firebox will be permitted for cooking and heating purposes during the ban.

The fire ban is effective immediately and will stay in place until the Ministry of Environment rescinds the order.

## NEW HIGHWAY CONSTRUCTION PROJECTS FOCUSED ON SAFETY



May 9, the Ministry of Highways and Infrastructure placed 24 projects worth an estimated \$65 million for tender to improve highway safety in Saskatchewan.

“Safety is the most important priority on our provincial highway system,” Highways and Infrastructure Minister David Marit said. “We are pleased with this year’s spring tender plan and the continuation of passing lane expansion throughout the province.”

Safety is the focus of the highway improvement projects released in the Government of Saskatchewan's 2018 Spring Tender Schedule.

Projects to construct passing lanes on Highway 4 between North Battleford and Cochin, and Highway 6 between the junction of Highway 39 and the Rowatt Access, as well as the twinning of Highway 7 around the Village of Vanscoy, point to the focus on safety.

## **SASKATCHEWAN APPLYING TO PARTICIPATE IN PIPELINE REFERENCE CASE BEFORE B.C. COURT OF APPEAL**

The Attorney General of Saskatchewan will be applying to participate in the reference case currently before British Columbia's Court of Appeal concerning the constitutionality of British Columbia's proposed amendments to its *Environmental Management Act*.

"We are dismayed that a pipeline that will benefit many people across Canada continues to be held up by unreasonable delays," Justice Minister and Attorney General Don Morgan said. "As we argued in the previous case involving the city of Burnaby, it is Saskatchewan's position that these pipelines are in the national interest and fall under federal, not provincial jurisdiction."

On December 7, 2017, the National Energy Board ruled that the Trans Mountain pipeline is not required to comply with the two bylaws cited by the City of Burnaby as its reason for delaying the issuing of permits to Trans Mountain. In its decision, the National Energy Board agreed with Saskatchewan that it would be contrary to a basic principle of federalism if one province, or a single municipality of one province, held the power to impede the construction of an interprovincial pipeline.

"Saskatchewan remains dedicated to standing up for the hard-working people in our natural resources and energy sectors," Morgan said. "We know that these pipelines are necessary for our energy companies to get their products to tidewater to ensure a competitive price, and that the increased capacity this pipeline represents stands to benefit all Canadians."

## **SASKJOBS.CA TO CONTINUE FOR THE NEXT SIX MONTHS**

The transition of saskjobs.ca to the partnership site with the National Job Bank will be extended for the next six months.

“Saskjobs has been an important website for both Saskatchewan employers and job seekers since 1999,” Immigration and Career Training Minister Jeremy Harrison said. “While the move to the National Job Bank website will offer more benefits to employers and job seekers, it has been challenging for some businesses and individuals to adapt. We have listened carefully to those concerns.”



On May 1, 2018, Saskatchewan deepened its existing partnership with the National Job Bank. The new site requires employers and job seekers to use the new platform which includes enhanced security, more benefits and a new look and feel.

“We will continue to engage saskjobs.ca users and ensure a more hands-on approach to the transition,” Harrison said. “The next six months will be spent engaging employers, job seekers and community partners about the upgrade.”

## **HIGHWAY CONSTRUCTION FOCUSES ON SAFETY IMPROVEMENTS**



With a Highways and Infrastructure budget of \$924.5 million this year, the 2018 highway construction season is underway. Construction will focus on improving safety on the provincial highway system as a result of a number of passing lane projects and other highway improvements.

“Our government is making a major commitment to improving safety on some of our busiest highways,” Highways and Infrastructure Minister David Marit said. “Constructing passing lanes on Highway 6, south of Regina for example, will greatly improve safety throughout this corridor.”

The two sets of passing lanes on Highway 6 between Regina and the junction with Highway 39

will be constructed this year. Construction will also begin in 2018 on two sets of passing lanes on Highway 4 between North Battleford and Cochin.

## **GOVERNMENTS OF CANADA AND SASKATCHEWAN SIGN AGREEMENT TO IMPROVE HEALTH CARE SERVICES**



Canada's universal, publicly funded health system is a source of pride for Canadians. The Government of Canada is working with provinces and territories to strengthen health care and to adapt the system to the changing needs of Canadians.

May 14, the Governments of Canada and Saskatchewan signed a bilateral agreement (<https://www.canada.ca/en/health-canada/corporate/transparency/health-agreements/shared-health-priorities/saskatchewan.html>) outlining how the province plans to invest its share of targeted federal health care funding. The agreement represents a shift in how the federal and provincial governments work together to advance shared health priorities. With support from the Government of Canada, the Government of Saskatchewan will invest in a range of initiatives to expand home and community care as well as mental health and addiction services.

“Saskatchewan is committed to improving access to health services for residents throughout our province,” Saskatchewan Health Minister Jim Reiter said. “This funding will help us address the need for better access to mental health and addictions services, and support our population in receiving health services in the most appropriate settings.”

## **3,700 MORE NURSES WORKING IN SASKATCHEWAN - A 29% INCREASE SINCE 2007**

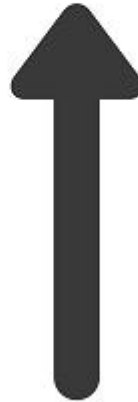

Access to health care continues to improve for Saskatchewan patients, thanks to 3,700 more nurses providing services than in 2007 - an increase of 29 per cent. In total, more than 16,000 nurses are licensed to practise in the province, including registered nurses, registered psychiatric nurses, nurse practitioners, and licensed practical nurses.

“Our government has shown strong commitment to recruit and retain nurses in Saskatchewan over this past decade,” Health Minister Jim Reiter said. “Nurses are highly valued members of the health care team, and their contributions are key to quality care for Saskatchewan residents. Working together with our nursing partners, I’m pleased with the solid progress we’ve made in increasing the nursing workforce.”

“We have more nurses in the province than any other time in our history,” Rural and Remote Health Minister Greg Ottenbreit said. “While we are pleased with this growth, we continue to work

with partners to recruit for vacant positions across the province.”

A number of nursing recruitment and retention initiatives have resulted in the increase of nurses in Saskatchewan, including:

- adding 300 new registered nurse/registered psychiatric nurse training seats;
- doubling nurse practitioner training seats from 20 to 40;
- offering clinical placement bursaries with a return-in-service commitment to rural and remote parts of the province; and
- providing grant funding to the Saskatchewan Health Authority to support recruitment and retention of hard-to-recruit positions.

Nurses are being recognized during National Nursing Week, May 7 to 13.

## **AFFORDABLE RENTAL HOUSING PROJECT OPENS IN SASKATOON**

The Governments of Canada and Saskatchewan along with Stewart Properties officially opened Star Court in Saskatoon, a newly-renovated 16-unit rental housing project that will help support low- to moderate-income households where an individual lives with disabilities.

Jean-Yves Duclos, Minister of Families, Children and Social Development and Minister Responsible for Canada Mortgage and Housing Corporation (CMHC), Social Services Minister and Minister Responsible for the Saskatchewan Housing Corporation (SHC) Paul Merriman, and Stewart Properties President Tyler Stewart, made the announcement today.

“These newly-renovated units play a foundational role in the positive quality of life for residents,” said Duclos. “Having access to safe, affordable housing along with purpose-built, accessible design features goes a long way to helping people achieve and maintain their independence. We are proud to invest in projects like this that have such a profound impact on lives.”

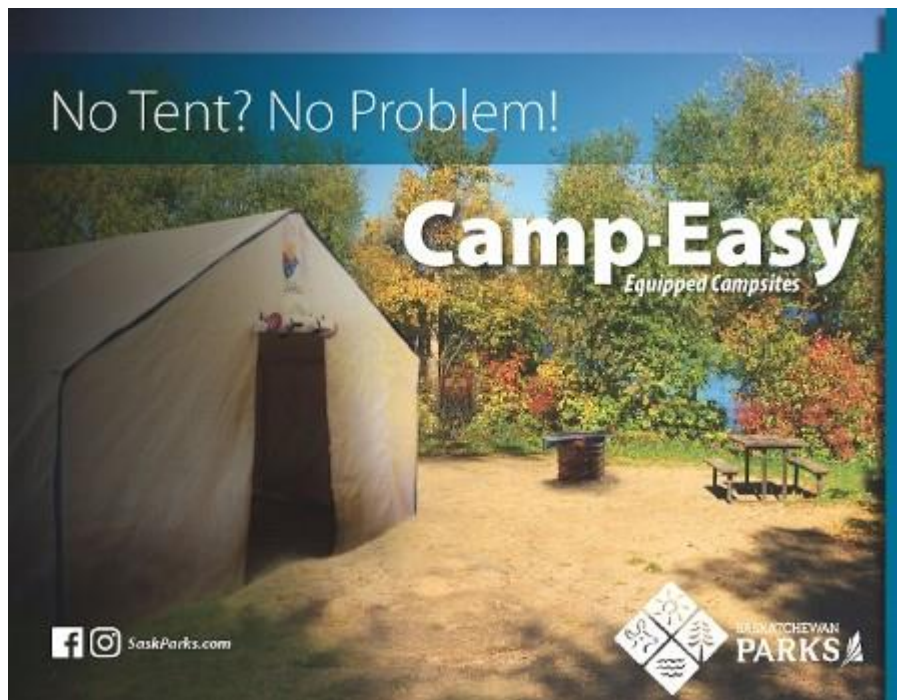

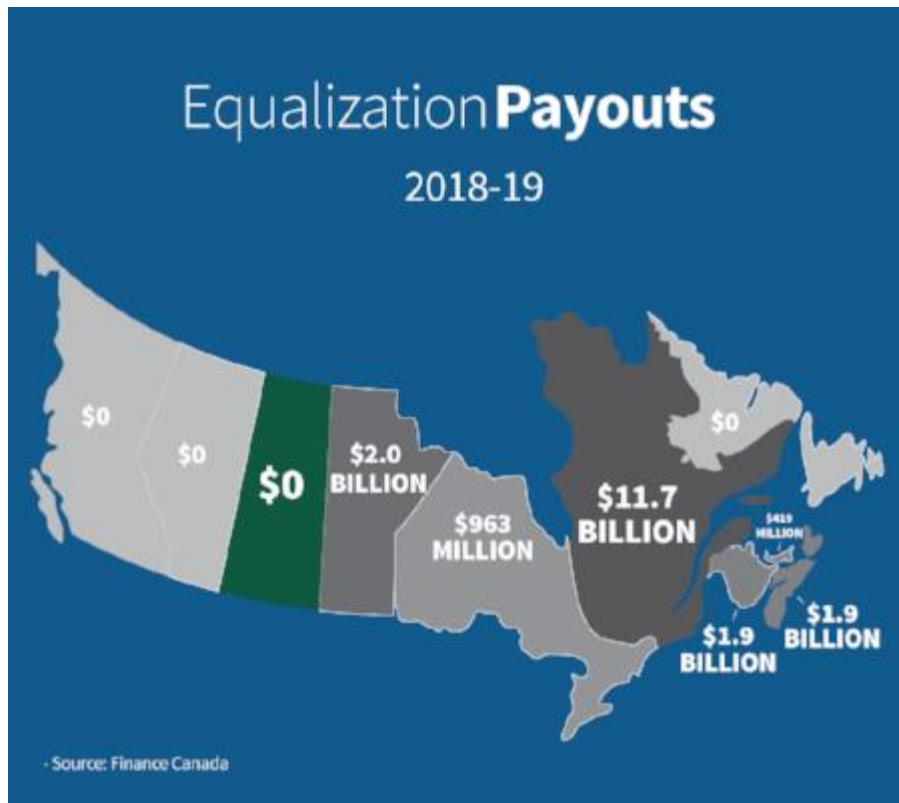

“We’re pleased to play a role in the delivery of an initiative that encourages and supports people in trying out an active and sustainable mode of transportation,” says Jay Magus, the City’s Acting Director of Transportation. “As we continue to move towards expanding transportation options around our city – with initiatives like new cycling infrastructure and Bus Rapid Transit – we’re going to see more and more people choosing alternatives to driving.”

# DID YOU KNOW

## REPORT FROM THE LEGISLATURE



The Government of Saskatchewan is investing \$14 million to improve rural roads, bridges and culverts throughout the province. The Municipal Roads for the Economy Program (MREP) provides funding for municipal roads impacted by increased truck traffic, as well as bridge and culvert projects.



**The rural municipal road system plays an important part in getting our exports to market. Our investment in MREP supports municipalities and plays an important part in keeping our economy strong. Administered by the Saskatchewan Association of Rural Municipalities, MREP grants cover up to 50% of the costs of road projects and 30 to 90% of the costs of bridge and culvert projects.**

**With this year's budget, our government has invested more than \$3 billion into highways and infrastructure over the last three years. This shows that our government understands the need to make our busiest highways safer, and to get our exports to market more efficiently.**

**A decade of growth means major safety improvements to many of Saskatchewan's busiest highways. Improvements include continued work on the Warman and Martensville interchanges; continued work on twinning Highway 7 between Vanscoy and Delisle; and starting a series of twinning and passing lane projects on Highways 6 and 39 between Regina and Estevan. Two sets of passing lanes will be built on Highway 6 between Regina and the junction of Highway 39 this year.**

**Two sets of passing lanes will be built on Highway 4 between North Battleford and Cochin; we are also beginning planning work for passing lanes on Highway 7 between Rosetown and the Alberta border, and Highways 9 and 10 between Melville and Canora. Planning work for passing lanes, widening and repaving Highway 5 between Highway 2 and Saskatoon is also underway. Two sets of passing lanes were opened on Highway 5 between Humboldt and Highway 2 last year.**

**In addition to these projects, this year's budget will see 800 kilometres of highway improvements across the province. Other highlights include \$13 million to repair flood damage or prevent damage in future years, and \$6.7 million to urban municipalities through the Urban Highway Connector Program.**

**We continue working to improve traffic safety and efficiency with the construction of largest infrastructure project in Saskatchewan's history – The Regina Bypass. On time and on budget for completion in 2019, the project includes 12 overpasses, 30 years of maintenance, 40 kilometres of new four-lane highway, 55 kilometres of new service roads, and 20 kilometres of four-lane resurfacing. The project involves 97 Saskatchewan-based companies and has created over 8,200 jobs.**

Over the last several years, our province has experienced significant emergency situations like flooding, wildfires and severe weather events. That's why it is so important to be emergency ready. This means knowing the risks, making a plan, getting an emergency kit and downloading the SaskAlert App.

SaskAlert notifies residents of emergencies in their area in real time so they can take action to protect themselves, their families and their property. 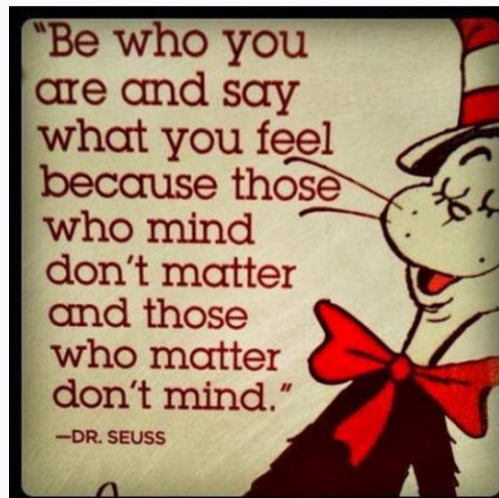
