## SASKATCHEWAN WAGES AMONG BEST IN CANADA

New data from Statistics Canada released today shows average weekly earnings in Saskatchewan were \$961.90 in February 2014, third highest in Canada. Nationally, the average was \$924.83.

"Saskatchewan's economy continues to make gains, and that's sustaining wages at one of the highest levels in the country," Economy Minister Bill Boyd said.

On a month-over-month basis, Saskatchewan's average weekly earnings increased by 1.8 per cent (\$16.68) compared to the previous month, ranking highest among the provinces, and above the national increase of 0.3 per cent.

"Higher wages offered here in Saskatchewan show employers are remaining competitive with other jurisdictions," Boyd said.





#### SASKATCHEWAN TO COVER NEW MS DRUG

Saskatchewan multiple sclerosis (MS) patients will soon have access to a new oral medication. Beginning May 1, 2014, the province will provide coverage of Tecfidera (dimethyl fumarate) to treat adult MS patients with relapsing-remitting MS who meet certain criteria.

"MS patients and specialists have been asking for coverage of this medication and our government is pleased to make it more accessible to those who need it," Health Minister Dustin Duncan said. "This option does not require injections, and has the potential to improve the quality of life for MS patients by reducing the number of relapses they experience and slowing the progression of the disease."

#### SASKATCHEWAN WORKERS HONOURED ON DAY OF MOURNING

Members of the Legislative Assembly honoured 35 people who died in 2013 as a result of workplace injuries with a moment of silence.

April 28 marks the National Day of Mourning, a day to remember those who lost their lives due to workplace injuries or illnesses. In 2013, more than 37,000 workplace injuries were reported to the Workers' Compensation Board.

"I offer my condolences to those who are dealing with the loss of a loved one as a result of a workplace injury or illness," Labour Relations and Workplace Safety Minister Don Morgan said. "Today is a day to honour the men and women who have lost their lives on the job and a reminder that workplace safety is the responsibility of everyone."

"Our most sincere sympathy to the families and loved ones of the people we are remembering today on the Day of Mourning," Saskatchewan Workers' Compensation Board Chairperson Gord Dobrowolsky said. "It is indeed a day to mourn these lives that were ended too soon. This is a day for all of us to recommit ourselves to Mission: Zero and to preventing needless suffering in the future."

"We are committed to supporting a competitive and productive employment environment by encouraging healthy, safe and fair workplaces, and by ensuring that our labour legislation provides flexibility to the modern workplace," Labour Relations and Workplace Safety Minister Don Morgan said. "This legislation and the associated regulations came from working collaboratively with our stakeholders and we believe the result is legislation that supports the needs of stakeholders in Saskatchewan – putting the safety and interests of working people first."
