

SASKATCHEWAN SMALL BUSINESSES WILL PAY LESS TAX ON MORE INCOME IN 2018

Following legislative amendments which were introduced today, small businesses in Saskatchewan will soon have the highest income threshold in Canada.

Effective January 1, the provincial small business income threshold-the amount of income up to

which small businesses pay tax at the much lower two per cent small business tax rate—is going up from \$500,000 to \$600,000.

"Small businesses are so vital to the health of the economy that our government decided to further enhance the Saskatchewan Advantage," Finance Minister Donna Harpauer said. "Increasing the income threshold to \$600,000 provides Saskatchewan small businesses with an incentive to hire more workers and invest new capital right here in our province. Meanwhile, rates for personal income tax in Saskatchewan continue to be reduced, which also helps create jobs." Read more <u>here.</u>

THREE TIPS FOR BOOKING WITH A TRAVEL AGENT



Travel agents can make planning a trip easy and effortless, but they often require large deposits of money up front. Many travellers pay deposits worth thousands of dollars by cheque, cash and credit to reserve their spots, but what happens if something goes wrong? What if the agency goes out of business?

You can take three steps to protect yourself in the event something goes wrong with a travel agency:

- 1. Pay with a credit card. It is easier to get a refund through a credit card provider.
- 2. Minimize or avoid cash/cheque deposits. It may be more difficult or impossible to get a refund if something goes wrong.
- 3. Do research, read customer reviews, check with the Better Business Bureau and the Association of Canadian Travel Agencies (ACTA) at <u>www.acta.ca</u>, and confirm that the agency is well established and has a good reputation within the community.

UNEMPLOYMENT RATE DROPS 5.9 PER CENT

Saskatchewan's unemployment rate dropped to 5.9 per cent in October from 7.0 per cent last year, tied for the third lowest in Canada (seasonally adjusted). Nationally, the unemployment rate was 6.3 per cent.

Our unemployment rate was down from 6.2 per cent in September. There were 565,800 people employed in October, down 3,400 from October 2016.

"We continue to see the impact of low resource prices on our labour market," Economy Minister Steven Bonk said. "However, having the third lowest unemployment rate in the nation shows Saskatchewan's economy is beginning to recover and that is a good reason to be optimistic about economic growth through the rest of 2017 and into next year."

Other October 2017 highlights include:

- Major year-over-year gains were reported for other services up 2,200; construction up 1,800; transportation and warehousing up 1,300.
- Saskatoon's employment was up 3,400 (+2.0 per cent) compared to last October.
- Regina's seasonally adjusted unemployment rate (5.4 per cent) was tied for tenth lowest, among major cities in Canada.

TOUGHER CONSEQUENCES FOR IMPAIRED DRIVERS WHO TRANSPORT CHILDREN



Longer Roadside Licence Suspensions, Vehicle Seizures if Kids Under 16 in Vehicle

Drivers with a blood alcohol content (BAC) of .04 or higher who transport children will face even longer roadside licence suspensions and vehicle seizures under legislation introduced today.

The Traffic Safety Amendment Act, 2017 implements an immediate seven-day administrative driving suspension on a first offence for a person who transports a child under the age of 16 and has a blood alcohol content (BAC) of .04 or higher, refuses to undergo a field sobriety test or fails a field sobriety test. This is an increase from the current three-day roadside suspension. This is in addition to any jail sentence, fine, demerit points and additional sanctions that result from the impaired driving conviction.

"Impaired driving is always a terrible choice, but willfully putting children at risk deserves additional penalties," Minister responsible for Saskatchewan Government Insurance Joe Hargrave said. "This legislation is another tool in our government's fight against Saskatchewan's impaired driving problem."

ATTORNEY GENERAL INTERVENES IN TRANS MOUNTAIN <u>PIPELINE PROCEEDINGS</u>

The Attorney General of Saskatchewan, concerned a British Columbia municipality is holding up a project that would create thousands of jobs for Canadians, has applied for intervenor status in the Trans Mountain Pipeline proceedings currently before the National Energy Board.

"We are disappointed the City of Burnaby is deliberately slowing down an important project for an industry that is only now recovering from the severe slowdown caused by low oil prices," Justice Minister and Attorney General Don Morgan said. "Saskatchewan has consistently taken the position that once an interprovincial pipeline has been approved by the federal government, provinces and municipalities should not be able to interfere."

"Our government will continue to advocate for an expansion of pipeline capacity across Canada," Morgan said. "Our energy companies need to get their product to tidewater to ensure they receive the best price possible. All Canadians benefit from a thriving energy sector, including the citizens of Burnaby."

NEW PROVINCIAL PARK IN SASKATCHEWAN'S PORCUPINE HILLS AREA




The Government of Saskatchewan is announcing the creation of a new park in the Porcupine Hills area, the second new provincial park created in the last five years.

Roads may be icy today. Here are some winter driving tips to stay safe:

- Clear snow from your vehicle and be sure your windows are completely defrosted before you drive.

- Slow down. Posted speed limits are for ideal driving conditions....


- Adjust your speed accordingly when conditions are less than favourable, like when roads are icy or there is low visibility.

- Leave more distance between your vehicle and the one in front of you, so you have more time to stop.

- Give yourself extra time to get to your destination so you're not tempted to drive too fast for road conditions.

- Turn on your headlights at night and any time visibility is poor, since some vehicles do not have taillights on when daytime running lights are being used.

NEW INTERNATIONAL TRADE CENTRE IN REGINA READY FOR BUSINESS



The now completed International Trade Centre at Evraz Place in Regina will open its doors to the world later this month. The facility was funded in part by the Government of Canada's Growing Forward 2 agreement.

November 6, the Regina Exhibition Association Limited (REAL) President and CEO Mark Allan toured several funding partners through the new, \$37 million centre. The fully-finished International Trade Centre will host its first major event, Canadian Western Agribition (CWA), from November 20-25, an event that attracts more than 120,000 visitors annually, including guests from 75 countries.

The 150,000-square foot, multi-purpose facility replaces a number of old buildings and barns, and will play a key role in major agricultural events such as Agribition and Canada's Farm Progress Show, in addition to hosting other major events and activities. The completion of the


