CANADA DAY CELBEBRATION



What a way to begin the summer! Trish, Paige and Carter and I had the

opportunity to attend the Optimist Canada Day Celebrations in Diefenbaker Park. Optimist Canada Day has been organized by the Saskatoon Optimist Club here in Saskatoon since 1967, when it started out as a celebration of Canada's centennial.

The Optimist club has grown the event from a 6 hour evening event, to an all day 8 am to 11 pm family day to celebrate the privilege and blessing of living in the best country in the world.

This year at the official ceremonies, the City of Saskatoon hosted the Lieutenant Governor of Saskatchewan, Dr. Gordon Barnhart, along with the Honourable Lynn Yelich, MP Kelly Block, MP Brad Trost, Justice Minister Honourable Don Morgan, and his Worship mayor Don Atchison. Also joining the ceremonies were representatives of the French community, the Military, Army and Navy, the RCMP, and Scouts Canada. Dr. Barnhart led the assembly of citizens through the 're-affirmation of citizenship' ceremony, where all in attendance repeated the oath of citizenship. That was followed by Chris Don Levy who sang a tremendous bilingual O Canada which was followed by celebration cake sponsored by Canada Safeway (it was 4 feet by 8 feet).

The Saskatchewan Intercultural Association provided entertainment for the 3 hours followed by 6 local bands, with the evening ending with spectacular fireworks!

The chair of Optimist Canada Day is Saskatoon Silver Springs constituent Brad Sylvester. Brad has been chair for 10 of the last 15 years, and organized the official ceremonies since 1995. I would like to personally thank Brad for his service to his community, as this is just one of the many projects that he is involved in to serve his city, his province and his country. CITY OF SASKATOON TAKES LEADERSHIP ROLE

The City of Saskatoon has signed a Memorandum of Agreement with Communities of Tomorrow which commits the City to work with other municipalities to develop innovative infrastructure in Saskatchewan. Saskatoon is one of 14 major centres in the province to sign onto North America's first Municipal Innovation Network.

Saskatoon will invest \$50,000 in the new Leveraged Municipal Innovation Fund launched by Communities of Tomorrow. City administration will be directly involved in choosing which innovative projects the fund supports.

The Leveraged Municipal Innovation Fund is a part of the Municipal Innovation Network established by Communities of Tomorrow, which brings together municipalities, private sector companies, and Saskatchewan's research community to collaborate on the development of new infrastructure products and services.

SASKJOBS TOPS 13,000 JOBS FOR SECOND STRAIGHT MONTH

Saskatchewan employers continue to create job opportunities in huge numbers. The Province's SaskJobs.ca website saw 13,035 job postings in June, a 45 per cent jump over June 2010. Employers from 327 Saskatchewan communities posted opportunities to the site. In the first six months of 2011, Saskatchewan employers posted 67,300 vacancies to the website, an increase of more than 13,000 over the same period in 2010.

The number of jobs posted in the Natural and Applied Science category jumped by 83 per cent. The Trades and Primary Industry categories accounted for 4,542 jobs - more than a third of the overall total, and about three quarters, almost 10,000 jobs were full-time.

Interest in applying for jobs continues to grow as well, with the number of visits to SaskJobs.ca jumping by 12 per cent over June of last year. SaskJobs hosted 821,000 visits in June - a record for that month. Once again, visits from outside of Canada saw a significant increase, with a year-over-year jump of 39 per cent.

SaskJobs.ca is Saskatchewan's largest job-matching website. The site provides job posting services free of charge for employers across the province and free résumé posting for job seekers from around the world.

CELEBRATING SASKATCHEWAN PARKS WEEK

Hutchinson also joined other provincial and territorial ministers responsible for parks in designating July 16 as Canada's Parks Day. Canada's Parks Day is an annual event celebrating the importance of Canada's national, provincial and territorial parks. The major goal of the day is to focus public attention on conserving Canada's natural and cultural heritage, in which parks play a major role.

UPDATE ON SASKATCHEWAN TEACHER BARGAINING

Representatives from the Saskatchewan Teachers' Federation (STF) and the Government-Trustee Bargaining Committee (GTBC) met with Labour Relations and Workplace Safety Minister Don Morgan to receive the report from the special mediator, Richard Hornung. With the receipt of the report, the mediation process has concluded.

While a tentative agreement was not achieved directly through the mediation process, both parties have agreed that the report and recommendations will form the basis of a tentative agreement. Based on this commitment and the recommendations of the report, both parties will collaborate on the preparation of an acceptable tentative agreement to be circulated to their respective members/principals.

The STF and GTBC have agreed not to make any further comment at this time.

SASKATCHEWAN PEOPLE EARNING MORE AND PAYING LESS IN TAXES

Saskatchewan Advantage Tax Cuts to Take Effect on Canada Day.

Saskatchewan residents are earning more and paying less in taxes, with average weekly earnings up 5.2 per cent just as lower provincial income taxes take effect tomorrow.

Saskatchewan residents will see an increase in take-home pay beginning July 1, 2011, as employers adjust their payroll deductions to reflect the income tax reductions announced in this year's provincial budget. The balance of the income tax reduction will be delivered when Saskatchewan residents file their 2011 tax returns.

The 2011-12 Budget announced a \$1,000 increase to the basic and spousal personal income tax exemptions, along with a \$500 per child increase to the exemption for dependent children.

The improvements result in a family of four paying no income tax on their first \$45,550 of earnings - the highest income threshold in Canada.

Saskatchewan workers are also earning more. According to a new report released today by Statistics Canada, average weekly earnings in Saskatchewan are now \$887.72 - an increase of 5.2 per cent over last year and the third-highest in Canada, behind only Alberta and Ontario.

Higher wages and lower taxes means Saskatchewan is moving forward.

Small businesses will also pay much lower taxes starting July 1, 2011. The small business tax rate will be cut by more than half from 4.5 per cent to two per cent.

CHAMBER ON BUSINESS LUNCHEON

These priorities include meeting surgical volume and wait time targets, improving medication safety, decreasing falls and falls-related serious injuries in Long Term Care, improving staff health and wellness and plan for the Children's Hospital.

She has a Bachelor degree in science, a Bachelor degree in education and a Masters degree in health services administration. Maura is a Fellow of the Canadian College of Health Service Executives and a surveyor for Accreditation Canada. Maura is the Board Chair of the Canadian Patient Safety Institute, and is on the boards of directors for the Association of Canadian Academic Health care Organizations, Saskatchewan Academic Health Sciences Network and Saskatchewan Health Quality Council. She holds a part time faculty appointment in the Department of Community Health and Epidemiology at the University of Saskatchewan. Maura has been recognized as one of the Top10 Women of Influence in Saskatchewan by Saskatchewan Business Magazine and as one of Canada's Top 100 Most Powerful Women by the Women's Executive Network.

PUBLIC ACCOUNTS REFLECT STRONG ECONOMIC RECOVERY IN 2010-11

The Public Accounts show the Saskatchewan economy recovered strongly in 2010-11, producing \$1.1 billion more revenue than expected at budget.

This was due mainly to improvements in tax revenue and in non-renewable resource revenue as the economy gathered strength following a global recession.

The stronger revenues allowed the government to make needed expenditures on third party capital projects, and the Saskatchewan Surgical Initiative as well as deal with flooding damage across the province. As a result, overall expense was \$841 million higher than anticipated.

The province finished the year with a pre-transfer surplus of \$96 million in the General Revenue Fund (GRF), or \$270 million more than expected at budget.

The Growth and Financial Security Fund (GFSF) finished the year with a balance of just over \$1 billion, up \$242 million from budget. Government general debt was unchanged from the previous year at \$4.1 billion.

Revenues were up from budget in all categories except federal transfers, including the following:

- Non-renewable resource revenue was up \$420 million, due mainly to higher Crown land sales and higher than expected oil prices.
- Tax revenue was up \$272 million due mainly to stronger than expected Corporate Income Tax, offset by smaller than expected individual income tax revenue.
- Crown transfers were up \$196 million, due mainly to a special Crown Investments Corporation(CIC) dividend for the Children's Hospital in Saskatoon.
- Expenses were up \$841 million from budget, including the following:
- Health was up \$346 million from budget due mainly to investments in the Children's Hospital, long term care projects, the surgical initiative, and new equipment.
- Agriculture was up \$97 million, mainly because of the Excess Moisture Program.
- Advanced Education was up \$89 million mainly for the Academic Health Sciences Centre and maintenance costs.
- Corrections, Public Safety and Policing up \$54 million, mainly due to flooding claims under the Provincial Disaster Assistance Program (PDAP).
- Social Services was up \$42 million, due mainly to rental housing development and social housing renovations.
- Energy and Resources was up \$40 million to pay for cleanup of abandoned uranium mines in northern Saskatchewan.
- Environment was up \$40 million for flood relief through the Saskatchewan Watershed Authority.
